

8<sup>th</sup> Grade Cedar Point Field Trip Information and Permission Slip – Thursday, June 15, 2017

The teachers of Bryant Middle School will be chaperoning our annual field trip to Cedar Point in Sandusky, Ohio on Thursday, June 15<sup>th</sup>, 2017. Students who hope to attend will....

- Have good attendance. Students with excessive tardiness and absences or truancy in progress will not be permitted to go.
- Turn in their completed permission slip with \$75 cash payment on time (last payment date is Wednesday, March 29<sup>th</sup>). There are 210 spots available for this trip. Tickets will be sold on a first come, first served basis.
- Have cleared all of their school fines and fees (classroom, textbook and library) by Friday, June 2<sup>nd</sup>.
- Passing ALL of their classes on June 9<sup>th</sup>.
- Any student assigned 3 or more detentions (including responsibility class) after March 27<sup>th</sup>, 2017 will forfeit his/her opportunity to attend and the money paid.
- Any student receiving a suspension after March 27<sup>th</sup> or having multiple suspensions during the year (3 or more) will be excluded from the trip.

We, the staff at Bryant Middle School, take the safety of your child very seriously. This is why the cooperation of your child is required for student safety and the success of the trip. We expect all behaviors will be within the guidelines expressed in our "student code of conduct". Though your child will be chaperoned by a Bryant teacher or staff member, your child will be on his/her own (with other Bryant students) for most of the day. For this reason, we want your child to have a timepiece (watch or cell phone with a clock) so that they will be on time for their "mid-day check-in" with their chaperone and the departure from the park at the end of the day. Carrying a cell phone is perfectly acceptable and even recommended.

As a parent, we expect that the information that you place on the permission slip is complete and accurate. Also, please make sure that you are on time at the end of the day to pick up your child. Please carpool if you can. This will make for a safer start and end to the field trip. Please understand that failure to meet the expectations required to attend the trip will result in forfeiture of any money paid.
