Congratulations! The Michigan Department of Education (MDE) is releasing the following 2012 and/or 2013 Cohort school(s) from Focus School status:

Dearborn High School William Ford Elementary School Howe Trainable Center and Montessori Woodworth Middle School Salina Intermediate 4 - 8

Your school's hard work and emphasis on data-driven decisions have narrowed the achievement gap between the top and bottom performing 30 percent of students in the above named focus school(s). Student achievement among the bottom 30 percent has improved and we hope this trend continues. However, a sense of urgency on these issues must remain for all schools and districts across Michigan. Our accountability system requires us all to focus on effective instructional practices and sustain the increases in student achievement made thus far. This is essential in order to meet our state's goal of 85 percent proficiency for <u>all</u> students by the 2021-22 school year.

All accountability requirements for this/these school(s) due to its Focus School status, including submission of the fourth quarter Quarterly Board Report, are immediately suspended. Although the released Focus School(s) will no longer be responsible for completing the Focus School Diagnostic in ASSIST, the MDE encourages schools to continue to focus on the implementation of a multi-tiered system of support, and with that, the impact of Tier One instruction and the implementation of Tier Two interventions.
